Fox Haven Square is a ground up development at the highly trafficked intersection of Kirk Road and North Avenue in St. Charles, IL. The project will create a lifestyle retail development to service the St. Charles, Geneva, Bartlett and surrounding communities.

The development team will curate and develop a unique retail and hospitality environment differentiating the project from existing offerings in the trade area.

Proven by current anchors already committed to the site, as well as the demographics of the surrounding communities, the demand exists to lure high quality operators to the development. The time is now to join an already impressive lineup of quality tenants at this one of a kind development.

- Ground-up development at a prominent intersection in St. Charles.

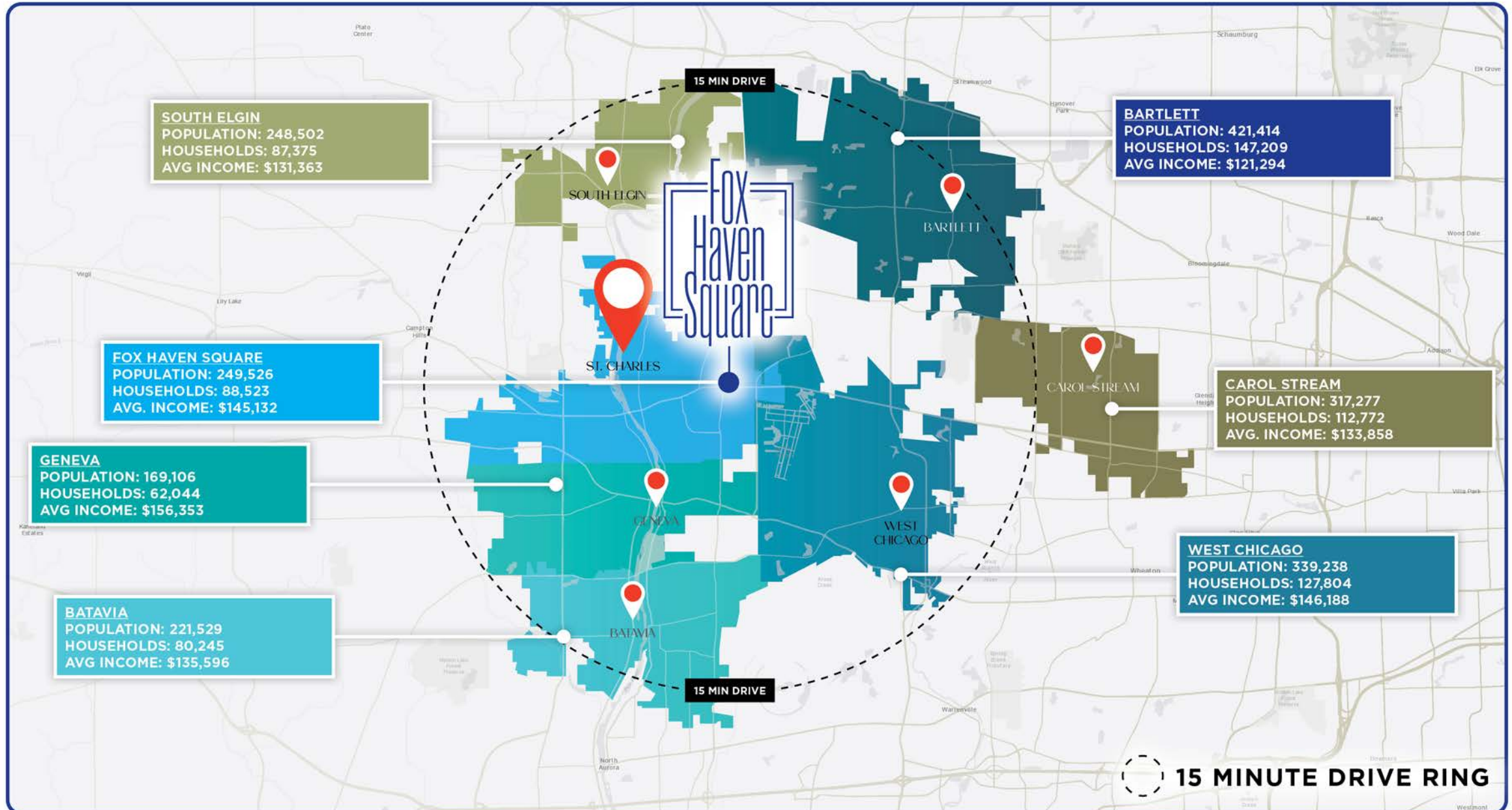

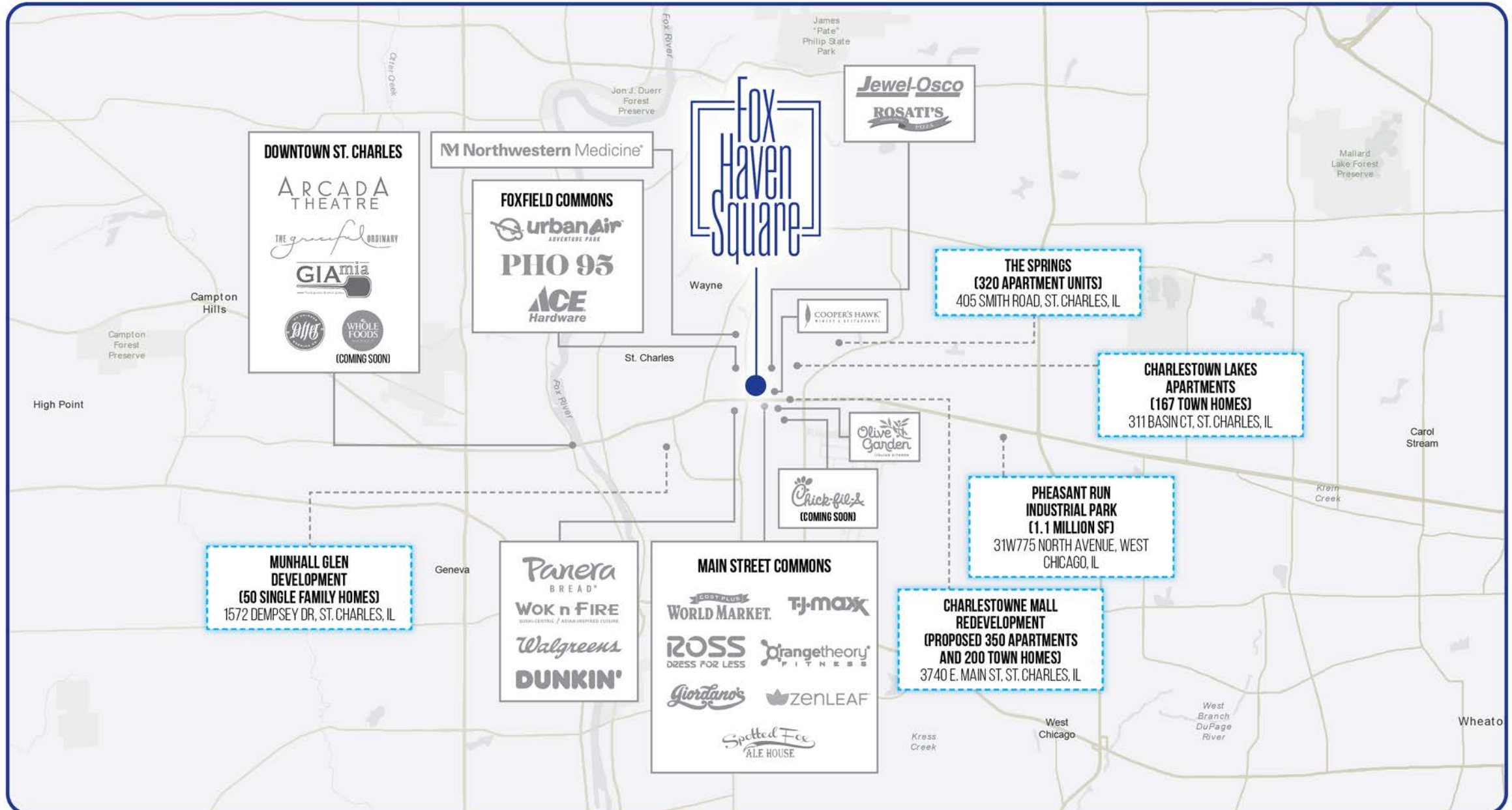

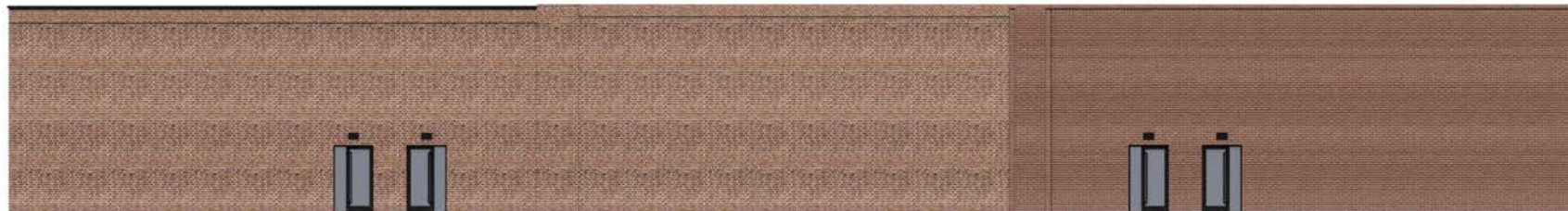
BUILDING 1 - SOUTH EXTERIOR ELEVATION
